LOCATION

The property is situated in Post House Wynd close to the junction with High Row in Darlington and Darlington Building Society on the corner. The location provides an ideal location for a mix of retail, leisure and business space uses.

Darlington Railway Station is approximately 0.5 miles distant providing mainline railway links to London King's Cross. Teesside International Airport is approximately 8 miles distant.

DESCRIPTION

A traditional building which provides creative business space for small business. It might be a beauty or clinical type use, massage, physiotherapy, counselling or an office with good sized private rooms accessed off the pedestrianised Wynd and adjacent to Darlington Building Society on High Row.

A ground floor lobby creates "shop front" reception for all occupiers to signpost their business to the upper floors.

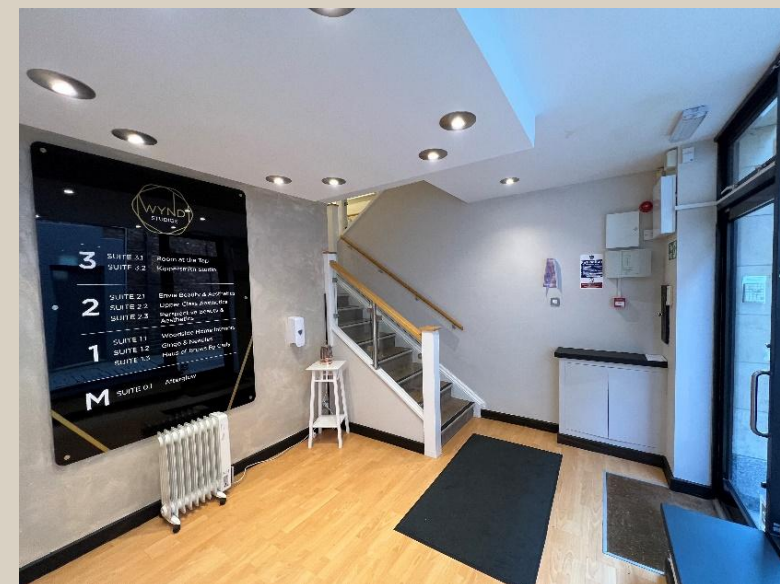

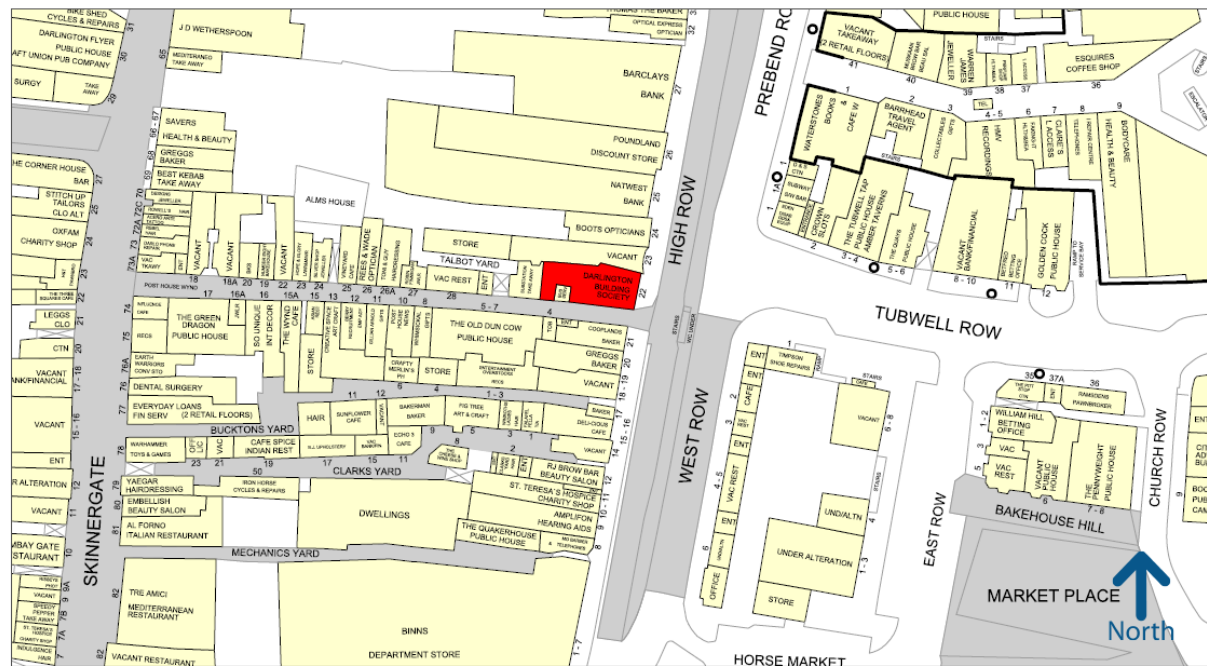
